President's Foreword to the Annual Report

The year has been one of change for AUSIT.

Our focus on providing services for members is starting to have a positive effect on membership numbers and is producing a general appreciation of the efforts we are making to give members value for their membership fees.

We have seen the departure of stalwart AUSIT national office manager, Judie Novak, and the "arrival" of a "national" David Connor (who was always with us anyway) and Yveline Piller in new roles inside a new administrative structure.

We have also been fortunate that despite the recent retirement of a number of valued office bearers there has been an influx of new faces bringing a new level of enthusiasm to our association.

Some of the year's highlights have

- · administrative reforms which will lighten the burden of state branches, which will now be able to dedicate themselves to providing professional development and other member services. The effect of this change will be felt in a major way over the next 12 months;
- the introduction of a 1800 number to improve communication with members and the public;
- expansion of the Yellow Pages "cooperative" advertising campaign to four major cities;
- progress on stage 2 of the website, with:
 - a) more information being added for members and for the general public b) behind the scenes
 - administrative enhancements to the online database
- improvements in professional development with an outsourced TAFE course in small business management skills pointing the way to the future of AUSIT services; the quality of workshops is improving and we are starting to produce video and audio versions of events for wider distribution to our members:
- the bulletin board and e-flash systems developed by David Connor continue to thrive, providing support and information to members and a lively forum for debate and information sharing (participating members have risen from about 180 in November to approx. 250 at the time of writing);

- the printing and distribution of thousands of AUSIT brochures through NAATI offices and public and private sector agencies helped to lift membership numbers, attract participants to workshops and raise AUSIT's profile in general;
- the decision to hold the AGM and National Conference in Perth for the first time, symbolic of our national scope and our desire to embrace all practitioners everywhere.

This was also the year when we started to take membership numbers seriously.

Membership drives in smaller branches helped to boost our membership numbers overall, so that at the time of writing membership nationally was at around 660, an increase of approx. 15% over the figure for November 2001. With 2500 respondents declaring themselves to be T&I practitioners in the ABS 1996 census our long-term membership target has to be that figure.

(A sign of the times is that our "overseas" membership has grown to rival a couple of our smaller branches for size. This has happened quite naturally, without any particular effort on our part.)

This newsletter, which is the last one before the National Annual General Meeting, is intended to resemble a corporate report and to serve a similar purpose. We will also see the AUSIT accounts in a consolidated format, providing a national perspective for the first time.

Rather than present branch and national reports "live" at the AGM itself when few people have an opportunity to read them and come to an informed judgment about issues affecting them, members will have the opportunity to read detailed reports now, in this newsletter, and reflect on them before the AGM itself.

Our focus in 2003 will continue to be on the issues touched on above, with more emphasis on promoting AUSIT nationally, because one of the best services we can provide to members is to make sure people know about us.

I thank all those members throughout Australia who assisted AUSIT during the year and I commend the Annual Report to the membership.

Membership

Committee Activities

The Committee met every fourth Wednesday, attending 11 sittings and contributing collectively 300 work hours. The average Committee Meeting attendance was good. I wish to thank and congratulate our Vice-Chair Ursula Hoffmann, who by her own admission has again put in the greatest number of hours for the good of AUSIT. I thank likewise all other Committee members.

The 2001 – 2002 year has seen much work take place in AUSIT at the national level. Communication between the States and between members has greatly increased, especially through the greater and more effective use of email. The State of Victoria in particular has become more active and in WA become more active and in WA much effort has gone into the organization of the National AGM and the Conference.

Change in Branch Executive Committee Operation

The Committee, in addition to myself, consisted of Marta Barany, Treasurer; and Susan Purvis, Christian Houllemanre, Yveline Piller and Eugenia Langley as Committee Members

In NSW the year since our last AGM has seen a number of changes in the way the Committee operates, and a greater input by members in the organization of workshops and seminărs.

There has been less work at the committee level, and this is in part due to the need to find new members who can become involved in the organization and coordination of State activities, but also because some of the 'old guard' have not been able to dedicate the time needed to ensure that activities be organised.

In terms of the operations of the committee, it was decided to call meetings on a less regular basis, and attempt to get members to become more involved in working groups with set objectives and priorities. The monthly meetings were thus discontinued.

Working Parties

A number of working parties were set up, including a Professional Development Committee (Workshops), a Marketing – Membership Committee, and a Professional Development Committee (Course Update).

The Professional Development Committee (Workshops) was very successful and organised five workshops this year. A Canadian academic, Professor Candace Seguinot presented one. It was also reproduced in videotape and supplied to other Branches. The last workshop was a cooperative effort with WA and was run as a teleconference, and the other was of the more traditional type – e.g. note-taking presented by Felicity Mueller both in Sydney and in Brishapa Brisbane.

The Professional Development Committee (Workshops) organisers, including Terry Chesher, Barbara McGilvray, Uli Priester, Felicity Muller and Helen Slatyer, should be thanked for their work and effort.

The Professional Development Committee (Course Update) has collected information on courses on T&I around Australia. Much still needs to be done in terms of putting together the material and identifying courses not strictly of T&I content that should be included as appropriate which would allow for professional development points when a formal policy in this matter is defined by AUSIT.

The Marketing-Membership Committee consisted of one person, Yveline Piller, the Administration Officer for the northern States. She has done much to follow up payments from people who had not remitted their membership fees, and to look at ways and means to attract new members.

Membership

There are 166 members in NSW, of which 34 have joined this year. The membership consists of 124 Ordinary, 30 Associate, 9 Affiliate, 1 Student and 2 Corporate members. Some work will be done on members (40) whose membership renewals are still outstanding.

I wish to thank the members who worked on the organization of workshops, and to the members of the retiring committee

I wish to thank some others as well, for the help given to me and for their untiring work and effort. In particular I wish to thank Marta Barany for her constant support and her dedication to AUSIT.

I take this opportunity to formally thank also all the members of AUSIT at a national level who have helped me over the years, as well as people in the T&I world (people working for NAATI, for other Government organizations, owners and managers of language service agencies, and people in the area of languages) with whom I have had the opportunity to work.

Since our last AGM we have had an end-of-year gathering, which was not well attended, and one seminar at the TAFE College on the subject of 'Computer Aided Translations', which was well attended, but predominantly by TAFE students.

We had planned for another seminar prior to our branch AGM on the subject of Mental Health interpreting, but our intended speaker could not participate, so it was decided to leave it till after our

Magdalena Rowan, the coordinator of the T/I course at TAFE, had been approached to have the seminars at the TAFE College, organised by AUSIT, but held at the college as 'extra-curricular' subjects for the T/I students, given that they have hear the producing t been the predominant participants in our seminars anyway, with invitations extended to all practising T/Is. We felt that the use of the TAFE venue would give more credence to the seminars or workshops offered, even though the past seminars had all been excellent. We also felt that this contact with students had the potential to promote AUSIT and bring in new membership

At this stage, for seminars held on a Tuesday evening the venue expenses are covered by TAFE However, other evenings may incur a fee, which AUSIT would be prepared to cover together with any charge for guest speakers etc.

Membership Drive

Brochures, members' application forms, State AGM and National AGM and Conference notices and a survey of all practising T/Is wishing AUSIT to represent them at enterprise bargaining negotiations were distributed to approximately 134 non-members. We have received about 10% response in the affirmative. However, I maintain that a professional association has the interest of all practicing colleagues, members or not, at heart. We have gained nine new members through this drive, two being from Northern Territory.

Magdalena Rowan was given brochures, application forms, State and National AGM notices for distribution to her TAFE Advanced Students (others being overseas students) and she was asked to encourage them to become members of AUSIT, attend our AGM and consider being involved on the committee.

Membership at the time of this Report going to press was a total of 35, with 28 Ordinary members and 7 Associate members. 4 of the Ordinary members live in the Northern Territory.

Enterprise Agreement

Last year the Interpreting and Translating Centre (ITC) asked us to vote on the 8% incréase which will come into effect as of October this year, with a further increase in October 2002.

The year 2003 should see the next round of ITC (Public Service) Enterprise Bargaining and I strongly feel that AUSIT should become involved as an association together with the PSA. Current published information indicates the following: following:

'Employees may represent themselves, ask their trade union, the Employee Ombudsman, or another agent of their choice to represent them.

Our branch should also make enquiries with both practitioners and private agencies re their rates of pay, contracts, mode of payment etc and see if any problems exist, and whether, if need be, we should

approach agencies for more equitable rates of pay and conditions for their employees. The Employee Ombudsman might be able to help us with any of these matters, be they Government or private agencies.

ITC Long Service Leave **Entitlements**

Erricos Neophytou, the ITC manager, orally informed us that the Auditor General has checked the process of calculation and considered it to be correct. Calculations have been made up to 2001 and they are currently calculating the 2002 figures. There were difficulties in working out how to make these calculations for casual employees who work such disparate hours.

Corporate Membership

Once the AUSIT constitution has clearly defined the Corporate Membership issue and this year's National AGM, SA branch should approach agencies and tertiary teaching institutions in them to become corporate members. to become corporate members This would give credence to their quest for quality NAATI accredited or recognised T/Is and service. AUSIT would be able to endorse and recommend the corporate members as being reputable providers of their services. We could all then work together for the improvement and maintenance of excellence in the field of T/I.

Centralised Administration

Our branch appreciates the benefits gained from the centralised administration.

We are now able to concentrate on Professional Development Programs and Recruitment Drives. The 1800 telephone number has reduced our branch expenses by eliminating the need to list our local Secretary's number and address and the White and Yellow Pages advertisements look more professional than in the past.

We could not wish for a better, more competent administrator than David Connor. Our thanks and best wishes go to him.

Future SA/NT Goals

- To canvass practitioners and to liase with TAFE as to what Professional Development Programs they wish to have. To continue our efforts with
- membership recruitment
- To make in-depth enquiries into AUSIT's ability to become involved with pay and employment issues for all practitioners.
- To approach Northern Territory again to encourage them to reform their branch and committee.

We extended our thanks to the ITC and the Manager Erricos Neophytou for kindly distributing our notices to T/Is via their regular mailings.

South Australia is pleased to see that the Jill Blewett Memorial Lecture, a South Australian initiative, continues to take pride of place in our National AGM.

I am very proud of our committee and grateful for the commitment of several members of the committee, such as John Crone, for his wisdom and encouragement, Chris Poole for his intelligence, experience, knowledge and generosity, Eva Hussain and Ilke Brueckner Klein who are my right and left hands on whom I can rely on to see the job through.

To be part of the committee means not just carrying out of administrative tasks, but also being involved in the process of learning and professional development.

One factor which was a stand out feature of this committee is unity. We have a conspicuous lack of internal political tension or disagreement and hence our outputs are greater than those of any other branch in the country. This is something I am very proud of and I am glad we are leading by example.

This year the focus for this committee has been "professional development", in line with the national theme. Thus at our strategic planning meeting in January, the committee decided on a number of projects for the year 2002. Some of these are new; others are the continuation of successful projects from the past. I shall now report to you the progress or outcome of these projects.

The Yellow Pages

This project was carried out by the Victorian Branch for AUSIT National and has nationwide scope. It will be reported on separately, but I would like to congratulate Silke Gebauer and John Crone who had the carriage of the project, on its success, after they achieved a similar satisfactory outcome with the Melbourne 2002 Yellow Pages Project.

Interpreter's Group
Janet Saba volunteered to be the co-ordinator for this project. The group meets on the first Friday every month. The first session took place in March and had a number of guest speakers including Chris Poole and Louis Vorstermans, who based with the group a formula for shared with the group a formula for business success as a professional nutrepreter. The session also featured Dr. Stynes, a psychologist, who, among other things, talked about the importance of "defusing" for interpreters, "defusing" meaning dealing with stresses in post-traumatic situations. Primarily, the sessions provide interpreters with the provide interpreters with the opportunity to discuss informally matters relating to interpreting with their colleagues and the group seems to be growing every month.

Small Business Management Course

Professional Development has been acknowledged as one of AUSIT's top priorities this year. It means a commitment to developing quality interpreting and translating services through provision of cost effective, flexible and relevant professional development programs for T&I practitioners.

The course, the brainchild of Eva Hussain, has been conducted by Holmesglen TAFE, consists of two full-day workshops of 6 hours per day and covers three modules of the Certificate in Small Business Management. Areas of study are Planning for Success, Cost, Profit and Breakeven and Marketing Professional Services.

Cost of training as a component of an accredited course is subsidized by the Victorian Government. The course is extended to Members and Non-members of AUSIT and has Non-members of AUSI1 and has resulted in 2 people joining AUSIT. The project officer, with support of Moreno Giovannoni, approached T&I agencies, with some agreeing to distribute course pamphlets. Forty people attended the courses; the first in April, the second in July. Provided there is enough interest, the course will be run again in October. The project officer has attempted to approach other Branches' training providers, with a view to extending the concept to other States.

Legal Interpreting CourseChris Poole, John Crone and myself have been working on developing and planning an 8 weeks course (2 nights per week) for interpreters who work regularly in legal interpreting. The course aims to provide interpreters with:

- The knowledge of the legal system in Victoria;
- An understanding of the protocols when working in different levels of courts, with police & lawyers, and prison officers;
- Practice & techniques in specialized area of legal interpreting such as: Telephone intercept & listening device

- preparation and simultaneous
- interpreting in court;
 The techniques on how to give evidence in court as an interpreter.

The course will run over January and February 2003 and the cost will be approximately \$200.00. A certificate will be presented on successful completion of the course, which will include a two-hour exam at the end.

All members of AUSIT are eligible to apply for the course. However to ensure that the course is representative of the demand for languages in legal interpreting we will be encouraging practitioners working in the languages of greatest demand to do the course, and if the course is overbooked preference will be given to these languages. We have carried out an analysis of language demand at the Magistrates Court and have also Magistrates Court and have also received data from VITS Languagelink on demand. The languages in highest demand are (in order) Vietnamese, Cantonese, Mandarin, Greek, Hakka, Arabic, Italian, Turkish, Russian, Spanish, Serbian and Cambodian.

Networking Session

This on-going project initiated by Filomena LoSchiavo continued to be a success thanks to Ilke Brueckner Klein. This year our guest speakers included Mr. Hasan Sayar from 3ZZZ and Dany Tedeschi from Inlingual Text. The committee runs 3 of these sessions per year giving its members an opportunity to network and be informed of what is happening in the Translating & Interpreting the Translating & Interpreting industry locally and overseas.

As one of the more dynamic Branches a number of our committee members also work with other members on a national level, to assist other AUSIT Branches and at the same time learn what others are doing interstate.

The committee also represents members on a number of external rembers on a number of external committees, to discuss relevant industry matters. These include RMIT Course Recommendation Committee, Court User's Forum, DIMIA Working Party. This Branch also participated in the Language Services Paview implemented by Services Rėview implemented by the Victorian Office of Multicultural Affairs. The report came out in July and is available from the VOMA website.

Membership

The Branch membership at the time of writing this report totalled 267, with 210 Ordinary members, 33 Associate, 5 Affiliate, 17 Student and 2 Corporate members.

Annual General Meeting

As the Branch AGM is not scheduled until September, the new incoming Committee is yet to be elected. The composition will be communicated to members at the National AGM.

The Western Australian Branch Mary Gurgone

Introduction

The present Branch committee, in addition to myself, includes Rossana Perino, Vice-Chair; Harry Blackmore, Secretary/Treasurer; and Committee Members Jean Page and Francine Giguere.

The Financial Year has been marked by great success in our membership drive thanks to efforts of both the National and State Committees.

Other highlights include professional development and attracting the National Annual General Meeting and National Conference to Perth for October 2002.

Professional Development During 2001, we continued to conduct our Professional Development (PD) activities jointly with the Western Australian with the Western Australian Institute of Translators and Interpreters (WAITI). Of particular note was the joint PD held at Christmas time. Dr Harry Blackmore delivered a program on "Stress Management" accompanied by a booklet that he produced for the event. The session came to an exciting conclusion with many stress balls being thrown around the room before sharing a congenial Christmas Dinner overlooking the river at East Fremantle. river at East Fremantle.

"TIS management changes" was conducted as a PD event by WAITI. AUSIT circulated the WAITI flyer so that the PD session was well attended by AUSIT members.

We also conducted our very first We also conducted our very first videoconference PD session involving members in WA and NSW listening to Mary Dickie speaking in Sydney on "Winning Jobs" in the new environment created by the changes in TIS management. We now are putting together a video of the event to ensure wide availability availability.

I was charged by the National Council to look into a possible PD system for AUSIT and have developed a concept for further discussion at the PD workshop as part of our National AGM and Conference event in Perth (25 October).

Membership Drive

The Branch undertook a highly successful membership drive that increased our membership from 47 to 67 members. This unprecedented growth was made possible by the additional benefits we were able to provide our new members (eg website, database).

National AGM and Conference
The National Council placed their
trust in the WA Branch to stage the
Annual General Meeting and conduct
a successful National Conference in Perth. The WA Branch set about the task involving WAITI members and AUSIT members in the Working Party.

We provided an update of progress to the National Council and will continue to do so on a regular basis. Key Successes:

In the special field of community interpreting for aborigines, we hope to have Dr Michael Cooke speak on Aboriginal Interpreters in Court and Mr Mark Simpson of Rio Tinto and Aboriginal Interpreters on the use of Lecturer on Aboriginal Interpreters on the use of
- Interpreters on the use of interpreters in mining companies JBML Dinner: In line with the suggestions made by the National President, we have made the event a dinner overlooking the Swan River, with an Aboriginal Elder welcome and Aboriginal singer to open the proceedings. Venue & Videoconferencing: The East Perth Campus of Central TAFE (5 mins. free city bus-ride) has a large videoconference screen and technician support to enable hook up with 3 other states for the AGM and Conference.

While the year has had its difficulties, we continue to show strong growth and are poised for a good national event in Perth. Our marketing of AUSIT and the Conference have been synchronous and resulted in increasing membership nationally.

Because the Branch AGM has been postponed, the present Committee will continue in office until it takes place after the National AGM.

The Yellow Pages 2003 Project Silke Gebauer & John Crone

Circumstances have made the Yellow Pages 2002 Project a pilot study for a more ambitious undertaking. The national scope of this cooperative project was just one of its two defining features. The other one was the fact that the project was in fact a synergistic effort between the participating members, who, by buying advertising space in fact "owned" the project, and AUSIT, which organised the facilitation in recruiting the Project Leaders and then piggy-backed its own Yellow Pages advertising on that of the participating members. In all, some 83 entries were obtained for inclusion in AUSIT composite advertisements in the 2003 Brisbane, Sydney, Melbourne and Perth Yellow Pages Directories. This compared with 89 entries that appeared in the AUSIT composite advertisements in the 2002 Melb appeared with 89 entries that appeared in the AUSIT composite advertisements in the 2002 Melb. (74 entries) and Syd. (15 entries) Directories. Separate institutional advertisements will appear for the ACT and SA/NT Branches.

The total amount received from members in advertising fees was \$33,864.80. AUSIT's contribution is not known at this stage, but will be within the budgeted parameters.

Considerable time and effort was required to promote the project throughout the various Branches This is something that will need to be taken into account when planning future Yellow Pages projects.

Apart from the particular logistical problems associated with a national as opposed to a state-based project, the 2003 Yellow Pages Project Team had also to cope with the ongoing debate over whether or not members should be allowed to advertise under their registered business name.

The Project Team were also expected to respond to members' changing needs and tastes, for changing needs and tastes, for example, their desire to have their name featured as prominently as possible in the advertisement. Members showed a marked preference for having their name appear as the only entry under a particular language heading. This had cost implications that ultimately dictated a different approach to the layout of the advertisement. advertisement

The layout of the AUSIT composite advertisements to appear in the 2003 Yellow Pages Directories will be uniform across all states. It will feature the AUSIT logo in blue as well as spacing between two or more entries appearing under a language heading.

Liaison between the Project Team Liaison between the Project Team and Pacific Access over layout and changes to copy was more effective than in 2002, with amendments being actioned on a day-to-day basis. This helped the Project Team come to terms with the different format and conventions associated with the computerized typesetting system Pacific Access is now using.



TREASURER'S REPORT

15th Annual General Meeting, Perth, 26 October 2002

In this report I will refer to the Yellow Pages advertising project; the National Office accounts which, until this year, were the only accounts reported on at the National AGMs; the consolidated accounts for the whole of AUSIT; provisions for answers to the questions members may wish to raise in relation to the financial information; and the administrative reform which will make use of the increase in AUSIT's technological capacity to ease the clerical burden on the branches and enhance the National Office capability at the same time.

At the time of writing the report, all accounts have been submitted by Branches, in one form or another. They have all been reordered in uniform format to enable efficient consolidation. Some required a little more attention than others, but all were ultimately satisfactory for the purpose.

The Yellow Pages Advertising

The main adjustment to the information as provided by the Branches is the treatment of the Yellow Pages Cooperative Advertising Project. When it was launched the last financial year the nature of the experiment was not precisely defined, but it has now evolved into a synergistic and cooperative venture of participating members, who buy advertising space, and AUSIT which provides facilitation and buys certain advertising exposure for itself.

The nature of the accounting difficulties caused by the uncertain circumstances at the beginning of the project caused the collection of money and the payment to Pacific Access Pty Ltd, the publishers of Yellow Pages, to occur in different ways in the two Branches involved in last year's exercise. Fortuitously, the NSW Branch collected all the money and made all the payments within the financial year under review. The balance was a relatively small excess of cost over collections and that, albeit technically debatable, was expediently charged to the Branch Profit and Loss Account. The initial uncertainty and the immateriality of the amount means that the possible technical shortcoming was of no consequence.

The situation in Victoria was more complex in that the collection of money took place in the financial year prior to the one under review and that the amount, in the absence of clear guidelines, was booked as Branch revenue, leaving the income unmatched by the anticipated expense. As a consequence, the Branch profit was technically overstated. The situation persisted into the year under review and it has obscured the financial position

of the Branch. Whereas the Branch Profit and Loss Account for the year shows a profit of \$5,751 the actual operations of the Branch, after eliminating the effect of the Yellow Pages figures, show a small operating loss of \$420. In presenting this report I have adopted the position that the Yellow Pages venture is not part of the AUSIT financial structure, and this report and accompanying financial statements have been prepared on that basis.

National Office

The National Office Balance Sheet and Profit and Loss Account, published in this report, require little comment. The revenue, as usual, is meant to be one half of the membership fees received either as renewals or new members contributions. This has not been the case in a few instances, and one of the consequences is that the apparent large increase in revenue is due to delayed receipt of the branches' contribution rather than an increase in revenues through increased membership, although it has had a contribution as well.

The Sundries income item of \$5,545 is made up of one-off and unexpected items, i.e. closing down of the separate Newsletter account in Adelaide, whose balance of \$2,261 was transferred to the National Office account; Trados advertising on the Website accounted for \$2,404; and late booking of last year's SA/NT Branch contribution of \$880.

Consolidated Accounts

This is the first time that Consolidated AUSIT Accounts are being presented to an AUSIT General Meeting. AUSIT has realised a surplus of \$11,880 during the year under review, but performances between branches vary, with the variability sometimes being a function of the branch size. The difference in membership fees between the "big" branches (Victoria/Tasmania and New South Wales) and the "small" ones also accounts for the difference. The figures are presented in the Consolidated Accounts report.

However, the year's results of the National Office are enhanced by added revenue received from the branches from revenues collected in the prior year. While the delay in forwarding the national share has no bearing on the overall financial performance, the branch business can be distorted, as the *Modified Consolidated Results* report shows. By delaying payments of their contribution to the National office, branches run the risk of over-

committing, as appears to be the case with the ACT Branch.

Members' Questions

This report and the attached financial figures are likely to prompt members to ask questions about various aspects of these reports. It would be highly desirable if members were to email, facsimile or snailmail their questions to either myself or the Branches in question before the AGM. The answer would then be provided to the membership in meeting and published in the post-AGM issue of the Newsletter.

The Administrative Reform

The administrative reform was conceived as a means of overcoming the inherent difficulties of volunteers carrying out administrative tasks for which they were not trained, compounded by the use of inadequate facilities. The objective was to use the Members' Directory, which is part of the AUSIT Website, to both maintain membership records available to the potential clientele and produce the required mechanism for maintenance of membership. The operating objective was to free the Branch Treasurers and other committee members involved in membership matters from complex and tedious clerical tasks, and supply systematic support for more productive efforts on their part.

Most of the work previously done in branches has been transferred to the two administrators, Yveline Piller in the Northern Region (QLD, NSW and ACT) and David Connor, an old AUSIT hand well known to most of our members, in the Southern Region (VIC/TAS, SA/NT and WA.). The use of the 1800 number has likewise eased the burden on the branches and concentrated the information provision in the way that will make it useful and consistent.

Although there has been slippage in the development of the system, we are already enjoying some benefits from the automation and expect its full operational efficiency in the near future. The changes in taxation and corporate administration that have accompanied the introduction of the GST have imposed on us certain disciplines that would be hard to achieve without this development. The experience I have had in recent weeks in producing these Consolidated Accounts has demonstrated beyond doubt that the reform will have very positive consequences for AÚSIT.

FIT Congress Vancover 2002

Adolfo Gentile was warmly thanked for his contribution as President of the International Federation of Translators (FIT) during the FIT Congress in Vancouver this August. Adolfo (member of the Victorian Branch of AUSIT) served a total of nine years on the FIT Council, the last three years as President. Linda Sivesind, from Norway, also completing her term of office on the FIT Council, asked for a special message to be sent to AUSIT with thanks for Adolfo's contribution to FIT over the years.

The first part of the Congress, known as the Statutory Congress (August 3-5), which was chaired by Adolfo, consisted of triennial executive reports, motions, amendments to the constitution, election of the new Council, and selection of the venue for the next FIT Congress (Tampere, Finland in 2005). On the second day reports were presented from FIT Regional Centres and FIT Committees, as well as FIT Member Associations. The **AUSIT Triennial Activity Report was** presented, as well as a report from FIT Committee on Community Based Interpreting, along with reports from the 45 delegations attending the Statutory Congress. AUSIT delegates were Adolfo Gentile, Helen Slatyer and myself.

The theme of the Open Congress (August 7-10) was Translation: New Ideas for a new century. Sessions were held on the following themes: Literary Translation, Translation Studies, Specialities in the interpreting profession: scientific, technical, legal and commercial, Terminology, Localization, Multimedia, Technology and Translation and Ethics, Status and Future of the Profession.

Helen and I jointly presented a paper "The Ethical Practices of Community Based Interpreters" on the international research we have been doing in our capacity as members of the committee on community based interpreting (CBI). Helen also presented a paper titled "The Translator's choice: bringing the Little Prince to life".

During the Open Congress, FIT Committees each held a meeting for conference participants to learn more about their committee activities, and we were pleased that the meeting of the CBI Committee was attended by delegates from Mexico, South Africa, the Netherlands, Denmark, Belgium, USA, as well as by Helen, Adolfo and myself. Participants gave a short presentation on CBI in their country

and we described the activities in Australia. Since the meeting, further expressions of interest have been received from Sweden, Italy and USA. The Committee plans to consolidate the committee, establish an associated interest group, setting up an email discussion group, and to work towards the creation of a database of CBI related information (e.g. organisations and structures specifically for CBI, country specific information, research, standards and training).

Further details on the FIT Congress will be forthcoming, on the AUSIT eBulletin and Website.
